#### Introduction

Fight Inequality Zimbabwe (FIA-Zim) intends to undertake a documentary that explores the linkages between the complex interplay of debt, inequality and essential services in Zimbabwe with a particular focus on Harare and Chitungwiza's water situation. The documentary will analyze how the Zimbabwean debt crisis has exacerbated existing inequalities and perpetuated a cycle of poverty and debt among vulnerable populations.

#### Background

Zimbabwe, once known as the "breadbasket of Africa," has faced a tumultuous economic landscape over the past few decades. Central to this crisis is the mounting national debt which has exacerbated inequalities across various sectors, notably in the provision of clean, safe and drinking water. This documentary explores how the debt crisis has deepened the divide between the rich and the poor, focusing on access to one of life's most essential resources: clean water. Zimbabwe's economic troubles began in the late 1990s with internal politics and policies deemed 'controversial' leading to strained relationships with the broader international community and a significant decline in key economic sectors such as agriculture, mining, manufacturing and tourism. Hyperinflation followed suit, peaking in 2008 while severely undermining public services including water supply systems. The government's inability to manage debt has led to severe cutbacks in essential services, disproportionately affecting the poorest communities. These poor communities in areas such as Chitungwiza, Glen View and Budiriro have been badly hit by government and local authorities' inability to provide clean water and remain hotspots for water borne diseases such as cholera and dysentery. This is in stark contrast to the situation in affluent neighborhoods who are least affected as they have the resources and ability to invest in other sources of clean portable water such as boreholes.

# **Objectives:**

The documentary will:

- Highlight how the Zimbabwean debt crises has exacerbated existing inequalities and perpetuated a cycle of poverty and debt.
- Analyze the policies and practices of organizations like the International Monetary Fund (IMF) and World Bank that often play a role in debt crises.
- Inspire viewers to advocate for policies that promote economic justice and reduce inequality.
- Uncover gaps in national policy & make a case for recommendations and resolution.

# Roles and Responsibilities of the Consultant:

- Craft a compelling film narrative that weaves together interviews, visuals, and narration.
- Organize travel and accommodation for the film crew.
- Capture high-quality footage of interviews, visuals and any necessary footage for the documentary.
- Conduct post production editing.

## Key Deliverables:

A documentary that highlights key issues on water inequality in Zimbabwe amidst the national debt crisis. The documentary should be subtitled in English for inclusivity.
